What Kinds of Trust Does a Democracy Need?

Democracy and trust have an essential but paradoxical relationship to one another. Democracies depend on trust among citizens so that we can count on others for help when we need them, security, and association for common goals. Trust in governments to provides us with conditions for good lives, including social welfare protections and supports. And yet the institutions of democracy were founded on distrust, especially of the powerful. What kinds of trust does a democracy need? How can we balance the distrust of power essential to democracy with the kinds of trust necessary for good, responsive government?

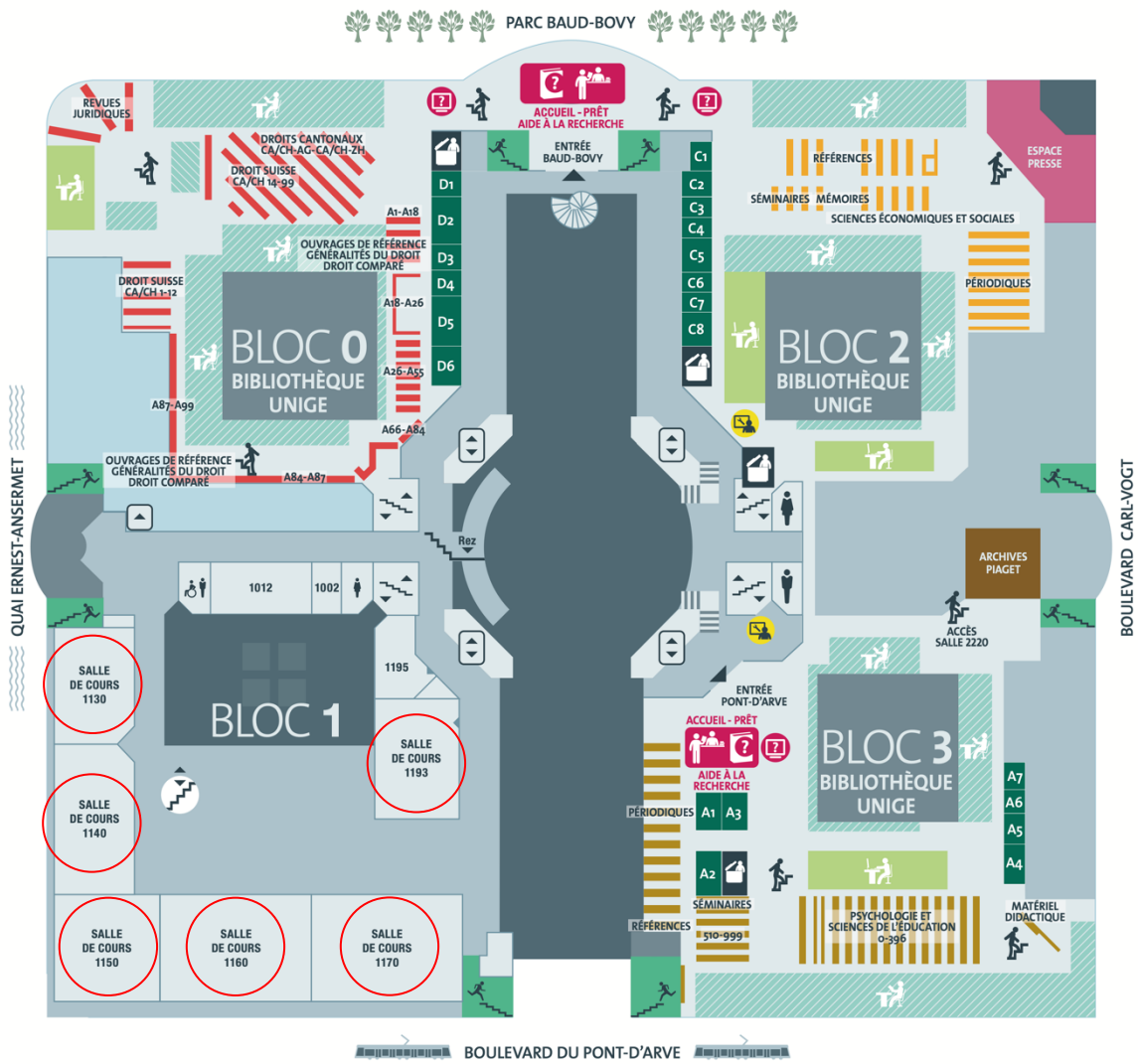

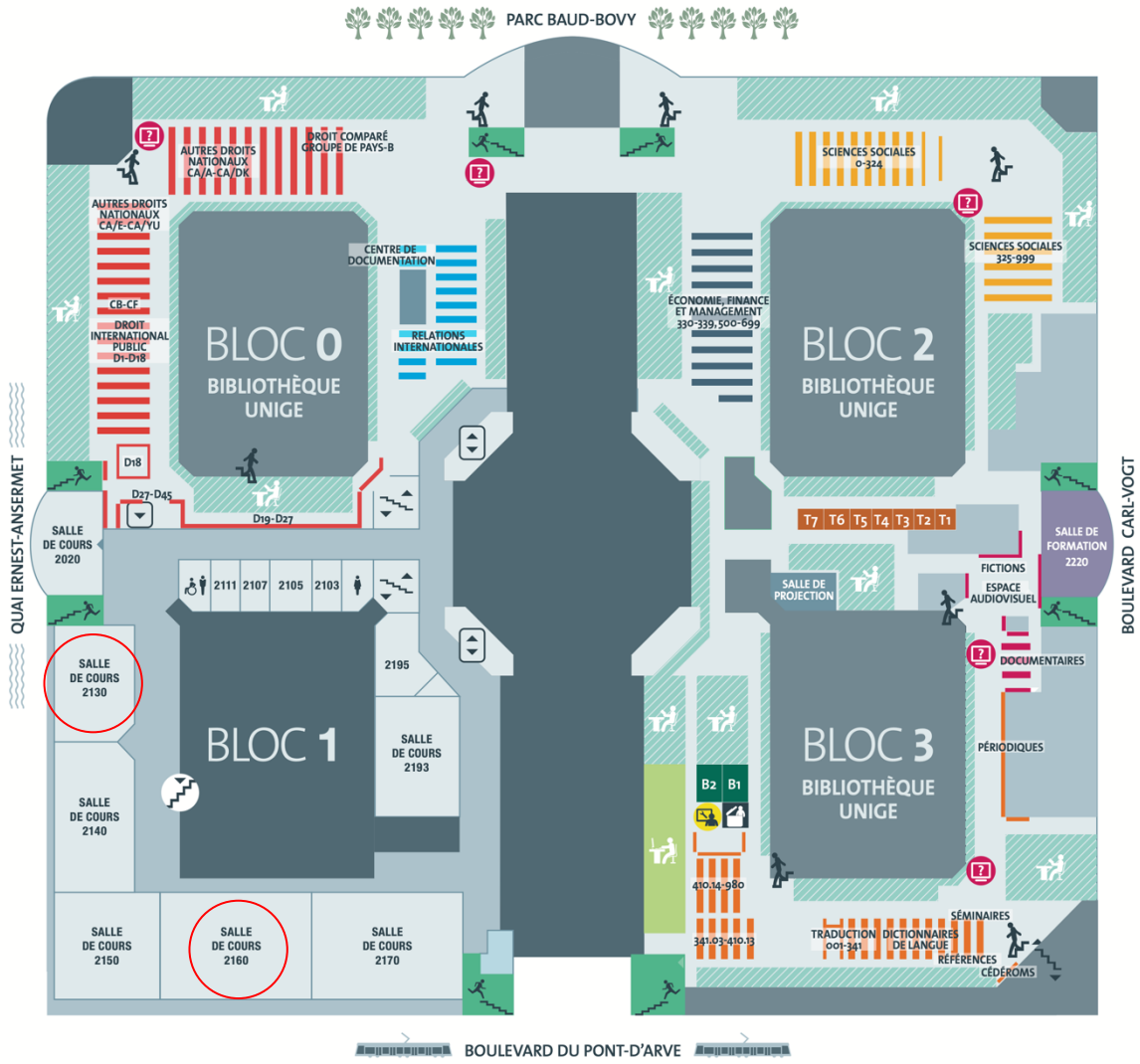

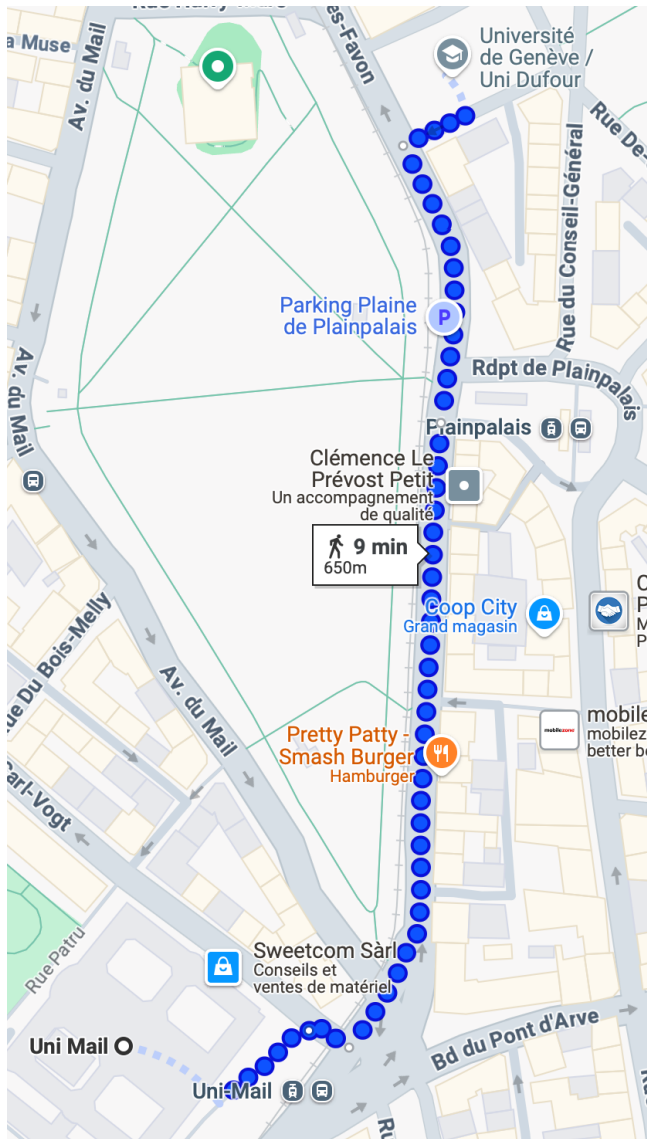
